**ANNOUNCEMENT OF RESOLUTIONS PASSED AT THE EIGHTH MEETING OF
THE SIXTH SESSION OF THE SUPERVISORY COMMITTEE OF
CHINA SOUTHERN AIRLINES COMPANY LIMITED**

The supervisory committee of the Company (the "Supervisory Committee") and all of its members confirm that the contents of this announcement does not contain misrepresentations, misleading statements or material omission, and jointly and severally accept full responsibilities for the truthfulness, accuracy and completeness of the information contained in this announcement.

On 27 August 2012, China Southern Airlines Company Limited (the "Company") held the eighth meeting of the sixth session of the Supervisory Committee at the Dalian City, Liaoning Province. The number of supervisors (the "Supervisors") supposed to be present was five, of which three attended in person. Supervisor Li Jia Shi, who did not attend the meeting because of business reasons, authorized Supervisor Liang Zhong Gao to attend the meeting and vote on his behalf; Supervisor Zhang Wei, who did not attend the meeting because of business reasons, authorized Supervisor Yang Yi Hua to attend the meeting and vote on her behalf. This meeting of the Supervisory Committee is chaired by Pan Fu, the chairman of the Supervisory Committee. The meeting was held in compliance with the relevant provisions of the Company Law of the People's Republic of China and the Articles of Association of the Company.

The following resolutions were considered and passed unanimously at the meeting:

1. Considered and approved the full text and summary of the 2012 interim report and results announcement (including the financial statements prepared in accordance with the People's Republic of China Accounting Standards for Business Enterprises and International Financial Reporting Standards).

All members of the Supervisory Committee reviewed the 2012 interim report and formed the following opinions:

a. the preparation and approval procedures of the 2012 interim report were in compliance with the requirements under the applicable laws and regulations, Articles of Association of the Company and the relevant internal corporate governance rules and regulations of the Company;

b. the contents and format of the 2012 interim report were in compliance with the relevant requirements of China Securities Regulatory Commission, Shanghai Stock Exchange and the Stock Exchange of Hong Kong Limited, and information disclosed therein reflected truly in all respects of the operational, management and financial status of the Company for the first half of 2012; and

c. none of the persons involved in the preparation and consideration of the 2012 interim report has committed any action in breach of confidentiality requirements in respect of the 2012 interim report.
